New Business:

a. Consider Sign Request by Friends of Fox Creek: Ian Bledsoe, President of Friends of Fox Creek, 76369 Ege Road, Rainier, OR 97048 stated on behalf of Friends of Fox Creek he was requesting permission to place another sign near Fox Creek. Bledsoe stated the sign would be 3' x 2' or 4' x 3', would be educational, and would also memorialize a deceased board member. Massey moved, Vilardi 2nd, to approve the request – **motion passed unanimously.**

Executive Session: ORS 192.660(2)(h) to consult with counsel concerning legal rights and duties of a public body with regard to current litigation or litigation likely to be filed.

- **f. Approve Pay Increase for Police Chief:** Mayor Cole said the increase is based on the contract between the City and the Police Chief **motion passed unanimously.**
